TERMINATION AND RELEASE
OF
TRADEMARK SECURITY INTEREST

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), dated as of December 31, 2009, is provided by the undersigned, Silicon Valley Bank, a California corporation with offices at 2400 Hanover Street, Palo Alto, California 94304 (the "Bank"), in connection with that certain Loan and Security Agreement dated August 15, 2006 by and between the Bank and Discrete Wireless, Inc., a Georgia corporation with offices at 1327 Northmeadow Parkway, Suite 150, Roswell, Georgia 30076-3861 (the "Company"), as amended (the "Loan and Security Agreement").

WHEREAS, the Bank and the Company entered into that certain Intellectual Property Security Agreement (the "IP Security Agreement"), dated August 15, 2006, pursuant to the terms and conditions of that certain Loan and Security Agreement by and between the Bank and the Company.

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office (the "PTO") on: (i) August 15, 2006, at Reel 3371, Frame 0233; (ii) November 10, 2008, at Reel 3885, Frame 0513; and (iii) October 23, 2009 at Reel 4085, Frame 0892.

WHEREAS, pursuant to the terms of the IP Security Agreement, the Company granted to the Bank a continuing security interest in and to all of the Company's right, title and interest in, to and under all of the trademarks and service mark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of the Company connected with and symbolized by such trademarks, owned by the Company, including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto and incorporated herein by reference, together with all goodwill associated therewith (collectively, the "Trademarks"); and

WHEREAS, the Company has paid all of its outstanding indebtedness to the Bank under the IP Security Agreement and the Loan and Security Agreement.

WHEREAS, the Bank has agreed to terminate and release its security interest and all of its right, title and interest in, to and under the Trademarks (under the IP Security Agreement and the Loan and Security Agreement) as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby terminates the IP Security Agreement and the Loan and Security Agreement, and hereby terminates, cancels and releases any and all security interests in, to and under and first priority liens on all of the Trademarks (under the IP Security Agreement and the Loan and Security Agreement), and the Bank hereby assigns and transfers to the Company all of the Bank's right, title and interest in, to and under the Trademarks (under the IP Security Agreement and the Loan and Security Agreement), effective as of the date set forth above.
