## RESTATED CERTIFICATE OF INCORPORATION

OF

International Fund Administration, Inc.

Under Section 807 of the Business Corporation Law

The undersigned, being President and Secretary of International Fund Administration, Inc., a New York corporation, hereby certify that:

1. The name of the corporation is International Fund Administration, Inc.
2. The certificate of incorporation of the corporation was filed with the Department of State on February 17, 1994.
3. The certificate of incorporation of the corporation is hereby amended to change the name of the corporation to BNY Alternative Investment Services, Inc. and to change the service of process to BNY Alternative Investment Services, Inc. and the text of the certificate of incorporation is hereby restated as amended to read as herein set forth in full.
4. The Restated Certificate of Incorporation was authorized by vote of the Board of Directors followed by the affirmative vote of a majority of all outstanding shares entitled to vote thereon.

As so amended and restated, the Certificate of Incorporation of the corporation will read as follows:

**FIRST:** The name of the corporation shall be BNY Alternative Investment Services, Inc. (the "Corporation").

**SECOND:** The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Business Corporation Law of the State of New York and any and all laws hereafter enacted which are amendatory thereof or supplemental thereto. The Corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency or other body without such consent or approval first being obtained.

THIRD: The office of the Corporation is to be located in the County of New York, State of New York.

FOURTH: The aggregate number of shares which the Corporation shall have the authority to issue is 200, all of which are to consist of one class only of 10 par value of : ---

FIFTH: The Secretary of State is designated as the agent of the Corporation upon whom process against it may be served and the post office address to which the Secretary of State shall mail a copy of any process against it served upon the Secretary of State is:

SIXTH: No director of the Corporation shall have any personal liability to the Corporation or its shareholders for any breach of duty in such capacity to the fullest extent permitted by the provisions of Section 402(b) of the Business Corporation Law, as the same may be amended or supplemented.
