## ASSIGNMENT FOR SECURITY

### (TRADEMARKS)

WHEREAS, Elgin Equipment Group, LLC, a Delaware limited liability company (the "EGL Parent") and Elgin Fastener Group, LLC, a Delaware limited liability company ("FGL Parent", and together with EGL Parent, each an "Assignor" and collectively, the "Assignors"), have adopted, used and are using, and hold all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, pursuant to the Joinder Agreement, dated as of the date hereof, by and among the Assignors and Wells Fargo Foothill, Inc., as agent for certain lenders (the "Assignee"), each of the Assignors were joined as parties to the Trademark Security Agreement, dated as of February 10, 2003 (as amended, restated or otherwise modified from time to time, the "Security Agreement"), in favor of the Assignee;

WHEREAS, pursuant to the Security Agreement, the Assignors have assigned to the Assignee, and granted to the Assignee for the benefit of the lenders, a continuing security interest in all right, title and interest of the Assignors in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of all Obligations (as defined in the Third Amended and Restated Loan and Security Agreement, dated as of December 31, 2009 among Elgin National Industries, Inc. a Delaware corporation ("ENI Parent"), the Assignors and certain Subsidiaries of ENI Parent and the Assignors identified on the signature pages thereof (such Subsidiaries, together with ENI Parent and the Assignors, each a "Borrower" and collectively, the "Borrowers"), the lenders time to time party thereto, and the Assignee as agent (as amended, restated or otherwise modified from time to time, the "Loan Agreement"));

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignors do hereby grant, assign, transfer and convey unto the Assignee for the benefit of the lenders, a continuing security interest in the Collateral to secure the prompt payment, performance and observance of all Obligations.

The Assignors do hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
