Pursuant to Section 48-21-107 of the Tennessee Business Corporation Act, the undersigned corporations hereby certify as follows:

1. Knoxville News-Sentinel Company ("KNSC") is a corporation organized and existing under the laws of the State of Tennessee. Scripps Howard Publishing, Inc. ("SHP") is a corporation organized and existing under the laws of the State of Delaware. Each of KNSC and SHP is a wholly-owned subsidiary of The E. W. Scripps Company, an Ohio corporation.

1. KNSC and SHP have entered into an Agreement and Plan of Merger dated December 4, 2009 ("Plan of Merger"), pursuant to which KNSC shall be merged into SHP (the "Merger") and all of the outstanding shares of capital stock of KNSC shall be cancelled. A copy of the Plan of Merger is attached to these Articles.

2. The approval of the sole shareholder of KNSC is not required. The Plan of Merger was adopted by the Board of Directors of KNSC on December 4, 2009.

3. The sole shareholder and the Board of Directors of SHP have taken all actions required by the laws of the State of Delaware and by the Certificate of Incorporation of SHP to authorize the Plan of Merger and the performance of its terms.

4. The Merger shall become effective at 10:00 p.m. EST on December 31, 2009.

AGREEMENT AND PLAN OF MERGER
OF
KNOXVILLE NEWS-SENTINEL COMPANY
WITH AND INTO
SCRIPPS HOWARD PUBLISHING, INC.

THIS AGREEMENT AND PLAN OF MERGER (this "Agreement") is made on December 4, 2009, by and between Knoxville News-Sentinel Company, a Tennessee corporation ("KNSC") and Scripps Howard Publishing, Inc., a Delaware corporation ("SHP").

1. At 10:00 p.m. EST on December 31, 2009 (the "Effective Time"), KNSC shall be merged with and into SHP (hereinafter sometimes called the "Surviving Corporation"), pursuant to and upon the authority of Sections 8-252 of the Delaware General Corporation Law and Section 48-21-102 of the Tennessee Business Corporation Act (the "Merger").

2. Each outstanding share of capital stock of KNS shall be cancelled.

3. Certificates or Statements of Merger shall be duly prepared, executed and acknowledged by the parties and thereafter delivered to the Secretary of State of Delaware and the Secretary of State of Tennessee (together, the "Certificates") for filing pursuant to the Delaware General Corporation Law and the Tennessee Business Corporation Act. From and after the Effective Time, the Merger will have all the effects provided by applicable law.

4. This Agreement may be executed in any number of counterparts, each of which when so executed shall be an original, but such counterparts together shall constitute one and the same instrument.

5. This Agreement has been approved and adopted by the directors and sole shareholders of Knoxville News-Sentinel Company and Scripps Howard Publishing, Inc.

6. The Merger may be terminated or abandoned by action of the Board of Directors of each of the entities that are party to the Merger prior to the effective time as set forth herein.

IN WITNESS WHEREOF, the undersigned have caused this Agreement and Plan of Merger to be signed by their respective officers, thereunto duly authorized, on the date first above written.
