**RELEASE OF SECURITY AGREEMENT AND RELEASE OF ASSIGNMENT  
FOR SECURITY TRADEMARKS**



WHEREAS, ASSIGNOR has fulfilled all of its Obligations as defined in the Security Agreement;

NOW, THEREFORE, the ASSIGNEE does hereby completely, fully and unconditionally release ASSIGNOR from that Security Agreement, and also completely and unconditionally releases ASSIGNOR’s security interest in and all claims and rights ASSIGNEE may have had in, to, and under the Trademarks and any good-will of the business symbolized by the Trademarks, as evidenced in that Security Agreement and Assignment for Security Trademarks.
