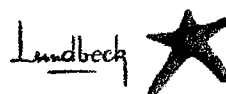

This letter is to inform you that effective as of March 18, 2009, Ovation Pharmaceuticals, Inc. was acquired by a wholly-owned subsidiary of H. Lundbeck A/S, an international pharmaceutical company based in Copenhagen, Denmark. The acquisition was completed by the wholly-owned subsidiary of H. Lundbeck A/S merging with and into Ovation Pharmaceuticals, Inc., with Ovation being the surviving entity. In conjunction with this merger transaction, Ovation changed its name to Lundbeck Inc. As a result of this name change, all existing marks formerly owned under the name Ovation Pharmaceuticals, Inc. are now owned by Lundbeck Inc.
