TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into, effective as of the 21st day of December 2009, by and between BIZWORLD, INC., a Florida corporation (in dissolution) with a principal place of business located at 4301 Gulf Shore Blvd. N., Suite 1404, Naples, Florida, 34103 ("Assignor"), and Dr. Leslie C. Norins, as Trustee of The Dr. Leslie C. Norins Trust, u/a/d/ 2/2/90, as amended, with a primary address of 4301 Gulf Shore Blvd. N., Suite 1404, Naples, FL 34013 ("Assignee") (together, "the Parties).

WHEREAS, Assignor owns the BIZWORLD Trademark and the BIZWORLD, INC. trade name, as well as U.S. Registration No. 2,048,225 for the BIZWORLD Trademark (collectively, the "Trademarks"), all depicted on Exhibit A attached hereto and incorporated herein by reference;

WHEREAS, Assignor desires to contribute, transfer, and assign all right, title, and interest in and to the Trademarks to Assignee, and Assignee desires to receive same;

NOW THEREFORE, in consideration of the sum of one dollar (\$1.00) and for other good and valuable consideration from Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Effective as of December 21, 2009, Assignor hereby sells, assigns, and transfers to Assignee, its successors and assigns, all of Assignor's right, title, and interest throughout the world in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and in connection with which the Trademarks are used; all registrations - including without limitation U.S. Registration No. 2,048,225, registration renewals, registration extensions, and applications for registration of the Trademarks that are or may be secured under the laws of the United States and all foreign countries; and the full right to sue for and recover all profits and damages recoverable from past infringements of the Trademarks.


2. All of the foregoing shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns, and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

3. The laws of the State of Florida shall govern all matters arising out of or relating to this Assignment, without giving effect to conflict of laws principles. In the event that such matter should arise, the Parties hereby consent to jurisdiction in the federal and/or state courts located in Collier County, Florida.

IN WITNESS WHEREOF, Assignor has caused these presents to be executed by its officers hereunto duly authorized as of this 7th day of January 2010.



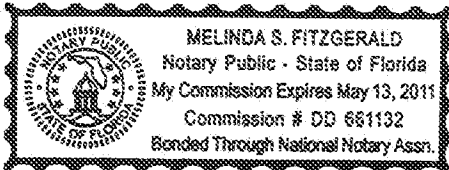


