Assignor irrevocably and unconditionally waives, disclaims and relinquishes any and all rights to claim ownership of any of the Marks following this assignment.

Assignor represents and warrants to Assignee that Assignor has the full authority to assign and transfer the Marks to U-Haul on behalf of themselves and their respective affiliated and controlled companies, officers, directors, and employees and relatives.

Assignor further represents and warrants to Assignee that prior to this Assignment, no person or business entity employed by, controlled by or related to Assignor, or any third party known to Assignor (other than Assignee), has any rights of any kind in the Marks, and that the Marks are free and clear of any claim of ownership, infringement, license or permission to use, encumbrance, lien or other claim or threat of claim.

Assignor further represents and warrants to Assignee that after this Assignment neither Assignor nor any person or business entity employed by, controlled by or related to Assignor will have any rights in any domain name, corporate name, business name, trademark or service mark of any kind which is made up in whole or in part of the Marks.



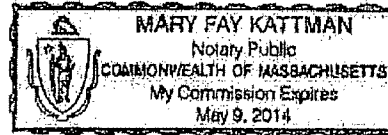
