RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST is dated as of January 15, 2010 and is made by Canadian Imperial Bank of Commerce, having a place of business at 1 King Street East, Suite 200, Kitchener, Ontario N2H 6N2 ("CIBC").

WHEREAS, CIBC and Insciber Technology Corporation, a predecessor of Leitch Technology International Inc. ("**Leitch**") having a place of business at 26 Pepler Street, Waterloo, Ontario, N2J 3C4, Canada, entered into a certain General Security Agreement, an Intellectual Property Security Agreement and a Confirmation of Grant of Security Interest all dated May 31, 2001 (collectively, the "**Security Agreement**");

WHEREAS, the Security Agreement granted CIBC a security interest in the trade marks, trade mark registrations and trade mark applications listed on Schedules A and B to this Release of Security Interest (collectively, the "**Trademarks**");

WHEREAS, CIBC recorded the Confirmation of Grant of Security Interest with respect to the Canadian Trademarks on June 26, 2001 in the Canadian Trademarks Office;

WHEREAS, CIBC recorded the Confirmation of Grant of Security Interest with respect to the United States Trademarks on June 7, 2001 at Reel 2320, Frame 0832 in the United States Patent and Trademark Office; and

WHEREAS, Leitch has requested that CIBC release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CIBC hereby agrees as follows:

1. CIBC hereby fully releases and terminates its security interest in the Trademarks.
2. CIBC further agrees, at the sole cost and expense of Leitch, to perform all acts reasonably necessary to effect the release of its security interest, including, but not limited to the recording, filing and entering into any agreements, documents, forms or papers needed to accomplish such release.
