TRADEMARK ASSIGNMENT  
BY AND BETWEEN

Mittal Steel Technologies Limited, a corporation organized and existing under the laws of Mauritius, having its head office at IPS Court, TwentyEight, Cybercity, Ebene, Mauritius, (hereinafter referred to as the "Assignor").

AND

ArcelorMittal, a Luxembourg "Société Anonyme", registered within the Trade and Companies Register of Luxembourg under number LUXBG B 82.454, having its head office at Avenue de la Liberté, 19 - L2930 Luxembourg, (hereinafter referred to as the "Assignee"),

Individually referred to as "Party" and collectively as "Parties"

RECITALS

WHEREAS the Assignor is the owner of pending or registered trademarks throughout the world as described in the Appendix

WHEREAS the Assignor is an affiliated subsidiary of the Assignee

WHEREAS within the corporate reorganization proceedings the Assignor consents to the assignment of its trademarks to the Assignee in consideration of a fair price

NOW THEREFORE in consideration of the mutual covenants and promises exchanged herein the Parties agree that the Assignor shall assign the aforementioned trademarks to the Assignee according to the following terms and conditions:

**1. Definitions**

Within the framework of the present assignment the Parties agree that the following terms and expressions are to be defined as follow:

- Trademarks shall mean all pending or registered trademarks listed in the Appendix and owned by the Assignor;
- Assignment shall mean this entire agreement together with the Appendix hereto.

**2. Assignment**

The Assignor hereby assigns to the Assignee full legal ownership of the Trademarks including but not limited to:

- all rights, title and interest in and to the Trademarks;
- any rights to prepare derivative marks;
- any goodwill related to the Trademarks;
- all rights to pursue all prosecutions;
- the right to sue and recover for past infringement of the Trademarks;

- all incomes, royalties or claims relating to the Trademarks due or payable on or after the date of this Assignment.

As from the effective date the Assignee is subrogated in the place of the Assignor in all rights relating to the Trademarks and shall be free to maintain, abandon, give license to and transfer them.

### 3. Statements

The Assignor has exclusive ownership of the Trademarks.

The Assignor also represents and warrants that at the effective date:

- the Trademarks are not the subject of any transfer of right, licence or co-existing agreement;
- it is able to provide evidence of use of the Trademarks worldwide upon request;
- it is not aware of any third party infringement of the rights to the Trademarks or any actions to contest the validity of the Trademarks or any registration thereof except any possible action arising during the course of the prosecution of the Trademark applications as mentioned in the Appendix but shall not be liable for any such occurrences happening before or after the execution of the Assignment.

The Assignee agrees and recognizes that at the effective date:

- that some of the marks constituting the Trademarks are not yet registered so that their scope may afterwards be reduced in the course of their prosecution or that they may be refused because of a third party's prior trademark or other intellectual property rights;
- it will acquire the Trademarks as is and with the protection they enjoy at the time hereof and expressly declares that it shall refrain from any claims, demands, actions or causes of actions against the Assignor in relation to the status, degree of protection or lack thereof or other characteristics of the Trademarks.

### 4. Consideration

As consideration for the Assignment of the Trademarks to the Assignee, the Assignee will pay to the Assignor the sum of US\$2,333,796.85 net of taxes (two million three hundred and thirty three thousand seven hundred and ninety six United States Dollars eighty-five cents).

This shall be paid within one month following the effective date.

### 5. Co-operation

The Assignor agrees to perform, execute or assist the Assignee upon request by taking any reasonable action that may be necessary for perfecting and securing the present Assignment including providing and signing all necessary documents required by the Assignee.

### 6. Effective date

The Assignment is effective as from the date of its signature by the last Party.

**7. Registration - Inscription**

Extended powers are given to the Assignee and holder of an original Assignment to require or make all proceedings relating to the registration of the present Assignment and to record the change of owner of the Trademarks within any national, foreign or international trademarks offices and any administrations.

The costs involved shall be borne as follows:

- the Assignor will bear all expenses relating to the recording of change of ownership of the Trademarks up to the date of recording of the Assignor as registered owner of the Trademarks;
- the Assignee will bear all expenses relating to the registration of the present Assignment and to the recording of change of ownership of the Trademarks from the Assignor to the Assignee.

**8. Governing Law - Jurisdiction**

This Assignment shall be construed, performed and enforced in accordance with, and governed by the laws of Luxembourg and the Parties irrevocably elect, for any matters arising under or in connection with this Assignment, the court of Luxembourg.

The present Assignment is established and duly signed in three originals intended for each party and a third for any necessary administrative requirement.
