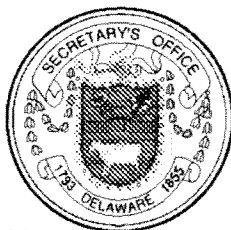

DOES HEREBY CERTIFY:


