TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination and Release") dated as of December __, 2009, from M&I MARSHALL & ILSLEY BANK (the "Secured Party") to DCTP ACQUISITION CORP. (N/K/A TULSA POWER, INC.), a Delaware corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of August 4, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan and Security Agreement") between the Grantor and Secured Party, the Grantor entered into that certain Trademark Security Agreement, dated as of August 4, 2008 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), in favor of the Secured Party, which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 11, 2008 in Reel 3850 and Frame 0810;

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Secured Party a security interest in, and a mortgage upon, all of its right, title and interest in, to and under the Trademark Collateral (as defined below); and

WHEREAS, the Secured Party now desires to terminate and release the entirety of its security interest in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. Definitions. The term "Trademark Collateral", as used herein, shall mean all of the Grantor's right, title and interest as of the date hereof in, to and under each of the Grantor's trademarks and trademark applications (including, without limitation, those items listed on Schedule A hereto).

2. Release of Security Interest. The Secured Party hereby terminates, releases and discharges its security interest in and mortgage over, all right, title and interest in, to and under the Trademark Collateral without representation, warranty or recourse of any kind or nature.
