TRADEMARK ASSIGNMENT

2. Any and all of Assignor's rights to royalties, profits, compensation, license fees or other payments or remuneration of any kind relating to the Marks and Transferred Rights arising after the Effective Date; and
3. Any and all of Assignor's rights to obtain renewals, and extensions of registrations or other legal protections pertaining to the Transferred Rights.
