Pursuant to Section 2.11 of the Texas Revised Limited Partnership Act, the undersigned organizations executed the following Certificate of Merger:

**FIRST:** The constituent business organizations participating in the merger herein identified are:

- (i) Lone Star Overnight, L.P., which is organized under the laws of the State of Texas, has a Texas Secretary of State file number 58230-10 and which is to be merged with and into;
- (ii) Lone Star Holdings, LLC which is formed under the laws of the State of Delaware and will be the surviving organization.

**SECOND:** The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent organizations in accordance with the provisions of subsection (b) of Section 18-209 of the Delaware Limited Liability Company Act, Section 2.11 of the Texas Revised Limited Partnership Act and the governing documents of each organization.

**THIRD:** The name of the surviving organization in the merger herein certified is Lone Star Holdings, LLC.

**FOURTH:** The Certificate of Formation of the surviving organization is the Certificate of Formation of the surviving organization in effect immediately prior to the merger.

**SIXTH:** A copy of the Agreement and Plan of Merger will be furnished by the surviving organization on request, without cost, to any member of the surviving organization or partner of the constituent organization.

**EIGHTH:** The surviving organization will be liable for the payment of any required franchise tax.


