ASSIGNMENT OF TRADEMARK RIGHTS

WHEREAS, Medical Measurement Systems, a New Hampshire corporation with its principal place of business at 100 Main Street, Suite 111 Dover, NH 03820 USA (“MMS”), and Alpine Biomed Corp., a California corporation with its principal place of business at 17800 Newhope St., Suite B, Fountain Valley, California 92708, (“Assignor”), have common law rights in the trademark that is the subject of this assignment and as shown in the attached Schedule A;

WHEREAS Assignor and MMS each own one-half of all right, title and interest in and to the trademark registration set forth in Schedule A and incorporated herein by reference (the “Trademark”);

WHEREAS, Sierra Scientific Instruments, LLC, a Delaware limited liability company with its principal place of business at 5757 W. Century Boulevard, Suite 660, Los Angeles, California 90045 (“Assignee”), is desirous of acquiring all of Assignor’s right, title and interest in and to the Trademark including the common law rights, registrations, and the goodwill associated therewith;

WHEREAS, Medical Measurement Systems BV, a company organized under the laws of the Netherlands with its principal place of business at Colosseum 25, 7521 PV Enschede, The Netherlands and sole shareholder of MMS (“MMS BV”) is desirous of acquiring all of MMS’s right, title and interest in and to the Trademark including the common law rights, registrations, and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged,

(a) Assignor does hereby assign unto Assignee all of its right, title and interest in and to the Trademark, together with that portion of its business relating to the Trademark and the goodwill appurtenant thereto.

Assignor agrees to execute and deliver, at the request of Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all of its right, title, and interest in and to the Trademark to the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Assignor.

(b) MMS does hereby assign unto MMS BV all of its right, title and interest in and to the Trademark and the goodwill appurtenant thereto.

MMS agrees to execute and deliver, at the request of MMS BV, all papers, instruments, and assignments, and to perform any other reasonable acts MMS BV may require in order to vest all of its right, title, and interest in and to the Trademark to MMS BV and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of MMS.

The assignment from Assignor to Assignee shall not be conditioned upon the execution of this Assignment by MMS and/or MMS BV and the assignment from MMS to MMS BV shall not be conditioned upon the execution of this Assignment by Assignee and Assignor.
