Quitclaim Assignment Agreement as to Security Interest

This Quitclaim Assignment Agreement as to Security Interest ("Assignment") dated as of December 23, 2009, is made between RUTL, Inc., a Delaware corporation ("Assignor") and Alan Dinow ("Assignee").

Assignor hereby irrevocably quitclaims, assigns and delegates to Assignee, without recourse to Assignor or any of its affiliates, and Assignee hereby irrevocably accepts and assumes from Assignor, without recourse to, or representations or warranties of any nature whatsoever by, Assignor, all of Assignor's right title interest, if any, in and to any security interest Assignor may have in the Thermacon tradename and trademark.

Assignor makes no representation or warranty and assumes no responsibility with respect to the execution, title, legality, validity, enforceability, genuineness, sufficiency, assignability or value of the collateral assigned. This Assignment is made AS IS, WHERE IS, WITHOUT ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND OR NATURE AND WITHOUT RECOURSE OF ANY KIND TO ASSIGNOR OR ITS AFFILIATES.
