
1. I was vice president of Champion Window Manufacturing and Supply Co., an Ohio Corporation, on May 1, 2007, the date on which the company was merged out of existence.


5. On May 1, 2007, all of the above marks became the property of and were assigned to Champion Window Manufacturing and Supply Co., LLC, as a result of the merger.
