THIS ASSIGNMENT OF TRADEMARKS (this "Assignment") is made and entered into as of this December 23, 2009, by ROMAN DECORATING PRODUCTS, INC., a corporation incorporated under the laws of the State of New Jersey, having a principal place of business at 824 State Street Calumet City ILLINOIS 60409 USA (hereafter the "Assignor"), for the benefit and in favor of PLB ACQUISITION LLC, a limited liability company incorporated under the laws of the State of Illinois, having a principal place of business at 824 State Street Calumet City ILLINOIS 60409 USA (hereafter the "Assignee").

WHEREAS, Assignor is the owner of the Roman Decorating Products trade name and the trademarks identified on the attached Schedule A, which is made a part hereof (hereafter the "Trademarks"), along with the goodwill of the business in connection with which the trademarks are used, and the applications and registrations therefor; and

WHEREAS, Assignor is the owner of the Internet Domain Names identified on the attached Schedule B, which is made a part hereof (hereafter the "Domain Names"); and

WHEREAS, in connection with the transactions contemplated by that certain Asset Purchase Agreement, dated December 23, 2009, by and among Assignor, Assignee and Hyde Group, Inc., a Massachusetts corporation (the "Purchase Agreement"), Assignee wishes to acquire and Assignor wishes to assign and transfer to Assignee all of its rights, title and interest in and to the Trademarks and the goodwill appurtenant thereto.

The Assignor hereby further confirms that it has the right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict therewith.

The Assignor will take whatever steps are necessary to transfer ownership and control over the Domain Names to Assignee.

This Assignment shall inure to the benefit of Assignee and its successors and assigns and shall be binding on Assignor, its successors and assigns.

This Assignment is made and accepted upon and subject to the provisions under the Purchase Agreement. Nothing contained in this Assignment shall be deemed to supersede, or modify any of the obligations, agreements, covenants or warranties of Seller or Purchaser (each as defined in the Purchase Agreement) contained in the Purchase Agreement. If any conflict exists between the terms of this Assignment and the Purchase Agreement, then the terms of the Purchase Agreement shall govern and control.

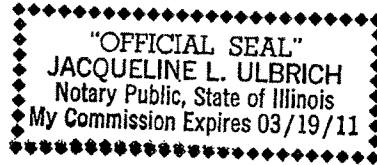
