TRADEMARK ASSIGNMENT

Playmates hereby sells, assigns, transfers and conveys to JSA Toys the entire right, title, interest in and to the Trademarks in the United States and all jurisdictions outside the United States, with the goodwill of the business connected with, and symbolized by the Trademarks, and together with that portion of the business to which the mark pertains, such business being ongoing and existing (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks), including all causes of action as may have accrued on or before the date of this Trademark Assignment, the same to be held and enjoyed by JSA Toys as fully and entirely as said interest could have been held and enjoyed by Playmates had this sale, assignment, transfer and conveyance not been made.

Playmates authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office, and in any applicable jurisdictions outside the United States, to record the transfer of the applications for these Trademarks to JSA Toys. Playmates agrees to further execute any documents reasonably necessary to effect this Assignment, or to confirm JSA Toys' ownership of the Trademarks.
