ASSIGNMENT

This ASSIGNMENT ("Assignment") is made and effective as of December 20, 2009 by Jobson Medical Information LLC, a Delaware limited liability company ("Assignor") in favor of The Vision Council, a District of Columbia not-for-profit corporation formerly known as Vision Council of America ("Assignee"), pursuant to the terms of the Agreement between Assignor and Assignee dated December 16, 2009 (the "Agreement").

WHEREAS, pursuant to and on the terms stated in the Agreement, Assignor has agreed to assign to Assignee all of all Assignor's right, title and interest in the mark VISIONWATCH (the "Trademark"), the goodwill associated with the Trademark, and U.S. Registration No. 3,384,634 for the Trademark (the "Registration").

NOW, THEREFORE, pursuant to the Agreement and in consideration of the premises:

1. Assignment. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Trademark and the Registration and the goodwill associated with the Trademark.
2. Governing Law. This Assignment shall be construed according to the laws of the State of New York applicable to agreements executed and to be performed solely within such State and without reference to any choice of law principle, provision or law.
3. Further Assurances. Assignor will execute, acknowledge and deliver all such further instruments or perform all such further acts as may be reasonably necessary or desirable, in the reasonable opinion of Assignee's counsel in connection with the assignment of the Trademark and the Registration.
