
#### 2. FURTHER ASSURANCES

Assignor agrees to execute, deliver and record such documents and instruments and do



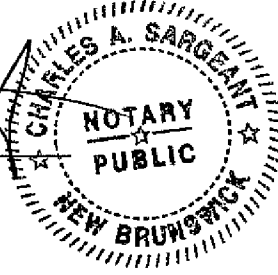
