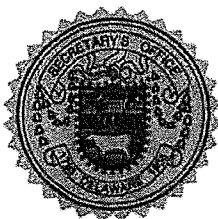

FIRST: That at a meeting of the Board of Directors of CONTECH ARCH TECHNOLOGIES, INC.
