RELEASE OF LIEN ON TRADEMARKS (SECOND LIEN)

This RELEASE OF LIEN ON TRADEMARKS (SECOND LIEN) (the "Release"), dated as January 27, 2010 is made by CREDIT SUISSE AG (formerly known as "Credit Suisse"), in its capacity as Collateral Agent ("Agent") for the financial institutions party to that certain Second Lien Credit Agreement, dated as of May 11, 2007, among Deluxe Entertainment Services Group Inc., DX Holdings LLC, the lenders party thereto and Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), in favor of DELUXE DIGITAL MEDIA MANAGEMENT, INC., a Delaware corporation, EFILM, LLC, a Delaware limited liability company, DELUXE LABORATORIES, INC., a Delaware corporation, SOFTITLER NET, INC., a California corporation, SHUG, INC., a California corporation, DELUXE DIGITAL STUDIOS, INC., a Delaware corporation, and MEDIA VU LLC, a California limited liability company (collectively, "Grantors"). Capitalized terms used herein and not otherwise defined shall have the meaning set forth in or incorporated by reference into the Credit Agreement.

WHEREAS, Grantors entered into that certain Second Lien Trademark Security Agreement, dated as of May 11, 2007 and recorded in the United States Patent and Trademark Office as of May 15, 2007 at Reel 003542, Frame 0364 (the "Trademark Security Agreement"), pursuant to which Grantors granted to Agent a security interest in and lien on all right, title and interest of the Grantors in certain trademarks, including U.S. registration number 2,892,643 for the trademark SHUGAR SHACK CHOCOLATIER and Design (the "Released Trademark");

WHEREAS, none of the Grantors currently own or in the past owned any right, title or interest in and to the Released Trademark;

WHEREAS, the security interest in and lien on the Released Trademark granted to the Agent pursuant to the Trademark Security Agreement was inadvertent error; and



WHEREAS, Grantors have requested that Agent release any and all interest it may have in the Released Trademark, and Agent has agreed to do so.


