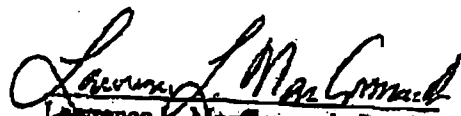
**CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION OF
