RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of the date of execution by State Street Bank and Trust Company, a Massachusetts trust company ("Releasor"), in favor of Iseli Nursery, Inc. an Oregon corporation ("Releasee").

A. Releasee and Releasor entered into a Security Agreement (the "Trademark Security Agreement"), dated April 16, 1997, which was recorded in the United States Patent and Trademark Office on August 6, 1997, at Reel 1618/Frame 0957; and

B. Releasor has agreed to release and discharge fully its security interest in the Trademark Collateral and assign, transfer, and grant all of its right, title and interest in the Trademark Collateral to Releasee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Releasor hereby releases its security interest in the Trademark Collateral and reverts Releasee with full right, title, and interest in, to, and under the Trademark Collateral.

1. Release. The Releasor, on behalf of itself and its successors, legal representatives and assigns, hereby terminates, fully discharges and releases in its entirety its security interest in and to the Trademark Collateral. Releasor hereby reassigns any and all such right, title and interest that it may have in the Trademark Collateral to Releasee.


2. Recordation. The Releasor hereby authorizes and requests the Commissioner for Trademarks of the United States to record this release of the security interest in the Trademark Collateral.



The Releasor hereby agrees to duly execute, acknowledge, procure and deliver any further documents, including, but not limited to, those documents necessary under the rules of the United States Patent and Trademark Office and Article 9 of the Uniform Commercial Code or other applicable law, and to do such other acts as may be reasonably necessary upon request by Releasee (or its assignees or designees) to effect the release of the security interest contemplated hereby and to confirm this Release and Releasee's (or its assignee's) right, title and interest in and to the Trademark Collateral.
