PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of January 26, 2010 (the "Effective Date") by Bank of America, N.A., as collateral agent (in such capacity, the "Collateral Agent") for the benefit of Hercules, Incorporated (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement, dated as of November 13, 2008, between the Grantor and the Collateral Agent (the "Security Agreement"), the Grantor pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to the trademark registrations and applications set forth on Schedule I hereto along with the goodwill associated therewith (collectively, the "Trademarks");

WHEREAS, the Security Agreement relating to the Trademarks was recorded with the Trademark Division of the U.S. Patent & Trademark Office on December 2, 2008, at Reel 3896 and Frame 0873;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Grantor.

The Collateral Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantor to more fully and effectively effectuate the purposes of this Release.

Other than the foregoing release of the Trademarks, the Collateral Agent hereby confirms its lien on and security interest in all right title and interest in and to all other Intellectual Property and other Collateral pledged to it under the Security Agreement.
