AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

Amended and Restated Trademark Security Agreement (this "Agreement") dated as of January 26, 2010 by and between O'CHARLEY'S MANAGEMENT COMPANY, INC., a Tennessee corporation, and 99 RESTAURANTS, LLC, a Delaware limited liability company (the "Grantors"), each having its chief executive office at 3038 Sidco Drive, Nashville, Tennessee 37204 and WACHOVIA BANK, NATIONAL ASSOCIATION, a national banking association, as Administrative Agent (the "Administrative Agent"), with offices at 1525 West W.T. Harris Boulevard, NC0680, Charlotte, North Carolina 28262, for the ratable benefit of the Secured Parties.

This Agreement is executed pursuant to the terms of (a) the Third Amended and Restated Credit Agreement dated as of January 26, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") by and among O'Charley's Inc., (the "Borrower"), the Lenders and the Administrative Agent and (b) the Third Amended and Restated Collateral Agreement dated as of January 26, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") executed by the Borrower and certain of its Subsidiaries in favor of the Administrative Agent, for the ratable benefit of the Secured Parties. Capitalized terms used herein but not defined herein shall have the meaning assigned to them in the Credit Agreement or the Collateral Agreement, as applicable.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor hereby confirms the grant pursuant to the Collateral Agreement, to the Administrative Agent, for the ratable benefit of the Secured Parties, of a continuing security interest in all of each Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:

- (i) all trademarks and all of the goodwill of the business connected with the use of, and symbolized by, each trademark of each Grantor, including, without limitation, each trademark listed on Schedule A; and
- (ii) all claims by the Grantor against third parties for (a) past, present or future infringement or dilution of any trademark, including, without limitation, any trademark listed on Schedule A or (b) injury to the goodwill associated with any trademark.

In the event that any provisions of this Agreement are deemed to conflict with the Collateral Agreement, the provisions of the Collateral Agreement shall govern. This Agreement constitutes an amendment and restatement of that certain Trademark Security Agreement dated as of October 18, 2006, by and between the Grantors and the Administrative Agent, effective from and after the date hereof.

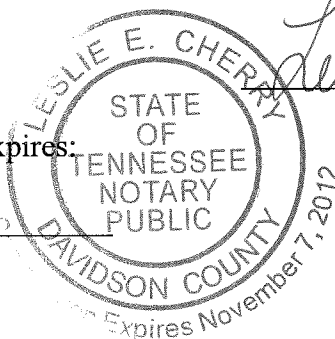
