AGREEMENT FOR ASSIGNMENT OF TRADEMARKS

- C. Assignee is the successor of Assignor in the business of seafood.

1. Assignment. For One Hundred US Dollars (US\$100.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby transfers and assigns to Assignee its entire right, title and interest and goodwill in the mark "SEA PASSION" and associated terms, designs, and logos. This transfer and assignment includes without limitation all common law, unregistered and registered trademarks, service marks, trade names and logos containing the term "SEA PASSION", and all goodwill appurtenant thereto.
