CERTIFICATE OF MERGER

OF

GALT VENTURES, INC.
(a Kansas corporation)

WITH AND INTO

GALT VENTURES OF KANSAS, LLC
(a Kansas limited liability company)

Pursuant to the provisions of K.S.A. 17-6003 and amendments thereof, Galt Ventures, Inc. ("the Company") and Galt Ventures of Kansas, LLC (the "LLC") do hereby submit the following Certificate of Merger and certify that the following facts relating to the merger (the "Merger") of the Company with and into the LLC are true and correct:

1. The name and state of incorporation of the constituent entities participating in the Merger herein certified are:

(i) Galt Ventures, Inc., a corporation duly incorporated and existing under the laws of the State of Kansas; and

(ii) Galt Ventures of Kansas, LLC, a limited liability company duly organized and existing under the laws of the State of Kansas.

2. An Agreement and Plan of Merger (the "Agreement") has been authorized and approved, adopted, certified, executed, and acknowledged by each of the aforesaid constituent entities in accordance with the provisions of K.S.A. 17-7705, and amendments thereto.

3. The effective date and time (the "Effective Time") of the Merger shall be upon filing of the Certificate of Merger with the Kansas Secretary of State.

4. At the Effective Time, the LLC shall be the surviving company, (the "Surviving Entity") of the Merger and the name of the Surviving Entity shall be changed to Galt Ventures, LLC.

5. At the Effective Time, without any further action on the part of the sole shareholder of the Company, the shares of common stock in the Company, issued and outstanding immediately prior thereto, shall be automatically converted into and be exchanged for the sole membership interest in the LLC.

6. At the Effective Time, the address of the registered office and the name of the registered agent at such address for the Surviving Entity is as set forth in the Articles of

Organization of the Surviving Entity. The officers of the Company shall be the officers of the Surviving Entity.

7. At the Effective Time, the organizational documents of the Surviving Entity, as filed with the Kansas Secretary of State and in effect immediately prior to the Effective Time, shall be the organizational documents of the Surviving Entity.

8. The executed Agreement between the aforesaid constituent entities corporations is on file at the principal place of business of the Surviving Entity, the address of which is as follows: c/o Speedy / Rapid Cash Companies, 3527 North Ridge Road, Wichita, Kansas 67205.

9. A copy of the aforesaid Agreement will be furnished by the Surviving Entity, on request and without cost, to any shareholder, member, or their equivalent, of any of the aforesaid constituent entities.
