**DECLARATION OF SUSAN J. HINCHEY**

I, Susan J. Hinchey, declare and state as follows:

- 1. I am Corporate Trademark Manager at Allergan, Inc. ("Allergan").
- 2. On July 28, 2006, Daniel Voorhees ("Mr. Voorhees"), a former paralegal at Allergan who was under my supervision, prepared an assignment document at my request to transfer certain marks owned by McGhan Medical Corporation to Allergan, Inc. (the "McGhan Medical Assignment").

3. When preparing the McGhan Medical Assignment, Mr. Voorhees inadvertently identified U.S. Reg. No. 1,141,242 dated November 11, 1980 for the mark LENS GLIDE as a registration to be assigned to Allergan (the "'242 Registration").

4. After preparing the McGhan Medical Assignment, Mr. Voorhees requested that Beki Osenbaugh ("Ms. Osenbaugh"), a temporary legal clerk at Allergan, (i) have the McGhan Medical Assignment executed by authorized representatives of McGhan Medical Corporation and Allergan, Inc., and (ii) electronically submit the executed McGhan Medical Assignment under my name to the U.S. Trademark Office for recordal.

5. On July 28, 2006, Ms. Osenbaugh had the McGhan Medical Assignment executed by authorized representatives of McGhan Medical Corporation and Allergan, Inc. and electronically submitted the executed McGhan Medical Assignment under my name to the U.S. Trademark Office for recordal against the '242 Registration.

6. The McGhan Medical Assignment was recorded in the Assignment Branch of the U.S. Trademark Office under Reel/Frame 3357/0616 and a copy of such assignment is attached hereto as Exhibit A.

7. Because McGhan Medical Corporation was not the owner of the '242 Registration when the McGhan Medical Assignment was prepared and recorded, the '242 Registration should not have been assigned to Allergan.


8. Because McGhan Medical Corporation does not have the power to transfer a registration it does not own, ownership of the registration never transferred to Allergan.

9. Alcon, Inc. is the correct owner of record in the Trademark Office as of July 27, 2006. Title to the '242 Registration should not be considered altered by the McGhan Medical Assignment. Alcon, Inc. or the last correct assignee has been and continues to be the owner of the '242 Registration.

10. This declaration is submitted in support of Allergan's submission to correct an error made in the assignment recorded at Rse/Frame 3357/0616 that erroneously affects the '242 Registration and is based upon my personal knowledge and upon the books and records kept in the normal course of business of Allergan.

I declare under penalty of perjury that the foregoing is true and correct.
