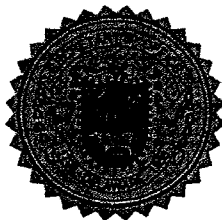


**FIFTH:** That the merger shall be effective on December 31, 2004.
