RELEASE AND REASSIGNMENT OF COLLATERAL TRADEMARKS

Reference is made to that certain Grant of Security Interest in Registered Trademarks, dated as of May 11, 2001, of FamilyTime.com, Inc., a Delaware corporation (the "Owner"), in favor of SI Venture Fund II, L.P., as Collateral Agent (the "Collateral Agent") pursuant to that certain Note Purchase and Security Agreement, dated as of May 11, 2001, as amended (the "Agreement"), recorded with the United States Patent and Trademark Office on October 9, 2001 at Reel 2417 Frame 0989.

In furtherance of, and to confirm for recordation and all other purposes, such termination and release, the Collateral Agent hereby terminates and releases any and all interest it may have in and to the trademarks described in Schedule A hereto, the goodwill of the business symbolized by said trademarks and the trademark registrations associated therewith as set forth opposite the name of each such trademark in said Schedule A (the "Trademarks"), including all renewal rights therein, the goodwill of the business symbolized by the Trademarks, the Owner's assets relating to the Trademarks, any and all license agreements now or hereafter existing with respect to the Trademarks, and all rights to any proceeds recovered for any past, present or future infringement of the Trademarks (collectively, the "Related Rights"), and hereby reassigns, conveys and transfers unto the Owner, its successors, assigns and legal representatives, all right, title and interest in the Trademarks and Related Rights granted to the Collateral Agent by reason of the Agreement or the Grant of Security Interest in Registered Trademarks.
