


AMENDMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Amendment") amends and shall be considered a part of that certain Intellectual Property Security Agreement (the "Agreement"), dated as of November 2, 2007, entered into between PACIFIC DATA DESIGNS, LLC, a Delaware limited liability company, now known as CLINOPS, LLC ("Grantor") and COMERICA BANK ("Secured Party"), which was filed and recorded in the Trademark Division of the United States Patent and Trademark Office on November 8, 2007, in Reel 36578, Frame 0784. Grantor and Secured Party agree as follows:
