PURCHASE AGREEMENT

This Purchase Agreement (the "Agreement"), made and entered into as of January 25, 2010, is by and among Envoy LLC, a Delaware limited liability company ("Emdeon"), FVT Holding, LLC ("FV Holding"), BBC Management, Inc. (FV Holding and BBC Management, Inc., collectively, the "Selling Equity Holders"), Devin H. Cox ("D. Cox"), Jeff Christensen ("J. Christensen"), The Jacob G. Banyai Irrevocable Trust, Sally B. Brinton, Kenneth M. McCorkle, The Eric S. and Stacie R. Falk Living Trust (BBC Management, Inc., D. Cox, J. Christensen, The Jacob G. Banyai Irrevocable Trust, Sally B. Brinton, Kenneth M. McCorkle, and The Eric S. and Stacie R. Falk Living Trust, collectively, the "FV Holding Members"), Bradley J. Banyai ("B. Banyai"), FVTech, Inc., a California corporation ("FVT"), FVTech Arizona, Inc., an Arizona corporation ("FVTA") (FVT and FVTA, together, the "Corporations"), LoriAnn Banyai ("L. Banyai"), and Eric Falk ("E. Falk") (L. Banyai, E. Falk, B. Banyai, the FV Holding Members, the Selling Equity Holders, and the Corporations, collectively, the "Interested Parties"), and (solely for purposes of Section 4.11 and Section 4.13) Emdeon Business Services LLC, a Delaware limited liability company ("EBS"). Capitalized terms used herein and not otherwise defined herein are defined as set forth in Annex A attached hereto.

RECITALS

WHEREAS, the FV Holding Members own all of the "Equity Owner's Interests" (as defined below) in FV Holding, which interests constitute all of the issued and outstanding equity interests of FV Holding; "Equity Owner's Interests" being described and defined for this purpose in that certain Operating Agreement dated effective as of December 30, 2009, for FV Holding (the "FV Holding Operating Agreement");

WHEREAS, the Selling Equity Holders own all of the "Equity Owner's Interests" (as defined below) (collectively, the "Interests") of FutureVision Investment Group, L.L.C., a Utah limited liability company ("FutureVision"; FutureVision, together with the Corporations, the "Target Companies"), which Interests constitute all of the issued and outstanding equity interests of FutureVision; "Equity Owner's Interests" being described and defined for this purpose as set forth in Section 3.1 of that certain Second Amended and Restated Operating Agreement dated effective as of October 1, 2009, for FutureVision (the "FutureVision Operating Agreement");

WHEREAS, B. Banyai owns all of the shares of capital stock of FVT and FVTA;

WHEREAS, the Selling Equity Holders desire to sell all of the Interests to Emdeon, and Emdeon desires to acquire all of the Interests from the Selling Equity Holders, for the consideration and on the terms set forth in this Agreement; and

WHEREAS, FVT and FVTA desire to sell the Corporation Assets to Emdeon, and Emdeon desires to acquire all of the Corporation Assets from FVT and FVTA, for the consideration and on the terms set forth in this Agreement;
