INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the "Agreement"), dated December 22, 2009, is made by and between Voyant International Corporation, a Nevada corporation ("Assignor"), and The Brown Family Trust, an Alaskan Trust ("Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to the pending patent application and trademark applications identified on Exhibit A attached hereto (the "Intellectual Property");

WHEREAS, the Intellectual Property was pledged as security for a certain debt obligation of Assignor, evidenced by one or more secured promissory notes (collectively, as amended, modified, restated, and/or supplemented from time to time, the "Note");

WHEREAS, the indebtedness evidenced by the Note is secured by, inter alia, that certain Guarantee and Collateral Agreement executed as of March 31, 2009, by Assignor, RocketStream, Inc., and Zeros & Ones Technologies, Inc (the "Collateral Agreement");

WHEREAS, Assignor is in default under the Note;

WHEREAS, Assignee has foreclosed upon the assets of Assignor, including the Intellectual Property, in accordance with the Collateral Agreement and applicable state law; and

WHEREAS, pursuant to the terms of the Collateral Agreement, Assignee desires to acquire, and Assignor has agreed to assign, all of Assignor's right, title and interest in and to the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby assign, transfer and convey unto Assignee all of Assignor's right, title and interest in and to the Intellectual Property, including without limitation all reissues, substitutions, reexaminations, divisions, continuations, continuations-in-part, foreign counterparts, extensions thereof, the goodwill of the business symbolized thereby by, and the right to recover damages and profits for past infringement thereof.

2. Assignor hereby covenants and agrees to reasonably assist and cooperate with Assignee to enable Assignee to enjoy to the fullest extent the right, title and interest herein conveyed in the United States and other countries provided, however, that the expenses incurred by Assignor in providing such cooperation shall be paid for by Assignee.

3. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and the State of Texas.
