ACCOMPANYING GOODWILL**



For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, all of Assignor's worldwide rights, title and interest in and to the service mark **NEOSPINE OUTPATIENT SPINE SURGERY CENTERS** (the "Mark"), including: (i) the registration therefor in the United States Patent and Trademark Office (U.S. Registration No. 3282751) issued on August 21, 2007; (ii) all renewals or extensions of that registration; (iii) all common law rights associated with the Mark; (iv) all rights in and registrations of the Mark in any other country or locality worldwide; (v) the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark; and (vi) the right to recover damages and profits for past, present or future infringements or unauthorized uses of the Mark, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor, if this assignment and sale had not been made.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute only one instrument.


