CONFIRMATORY TRADEMARK ASSIGNMENT

1. Assignor hereby confirms, *nunc pro tunc*, its assignment of all right, title and interest in and to the ULCEREASE mark to Assignee, including all goodwill associated with the ULCEREASE mark and the right to collect damages for past infringement or other violation of the ULCEREASE mark.
2. The parties agree that this confirms a prior assignment between them for which good and sufficient consideration was received.
