## RELEASE OF SECOND LIEN TRADEMARK SECURITY INTEREST

This Release of Trademark Security Interest is dated as of February 9, 2010. (ii) All proceeds of the foregoing, including without limitation any claim by Assignors against third parties for damages by reason of past, present or future infringement or dilution of any trademark, trademark registration or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark application, in each case together with the right to sue for and collect said damages.

The Assignee hereby represents and warrants to the Assignors that it has not, directly or indirectly, by operation of law or otherwise, assigned, transferred or conveyed any of its rights or obligations with respect to the Agreement or any trademark, trademark registration and trademark application listed on Schedule A hereto.
