Pursuant to the provisions of The General and Business Corporation Law of Missouri, the undersigned Corporation certifies the following:

SECTION 1

The present name of the Corporation is Turley Martin Tucker Company, the name under which it was originally organized was West Gate Management, Inc.

SECTION 2

An amendment to the Corporation's Articles of Incorporation was adopted by the shareholders on January 11, 2010.

SECTION 3

Article One of the Articles of Incorporation is amended to read as follows:

The name of the Corporation is: Cassidy Turley Midwest, Inc.

SECTION 4

Of the 1,000 shares outstanding, 1,000 of such shares were entitled to vote on such amendment. 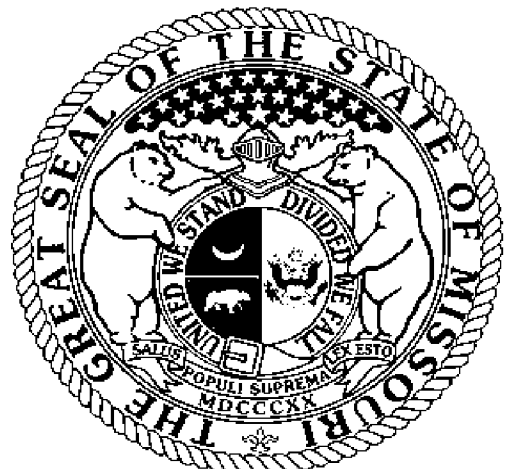
