## TRADEMARK ASSIGNMENT

This ASSIGNMENT (the "Assignment") is made effective as of February 11, 2010, by and between Kevin S. Parikh, Esq., an individual ("Assignor"), and AVASANT GLOBAL HOLDINGS, a California corporation ("Assignee").

1. The Assignor is the record owner of the Trademarks identified by Application Serial Numbers 77/562,804 and 77/562,806, for the marks AVASANT (design mark) and AVASANT (word mark), respectively, and currently pending registration before the United States Patent and Trademark Office.
2. Assignor is the sole and exclusive owner of the entire and unencumbered right, title and interest in and to the Trademarks, free and clear of any liens, charges and encumbrances, including, without limitation, licenses and covenants by Assignor not to sue third persons, and Assignor hereby assigns to Assignee, its successors and assigns, its entire right, title and interest in and to the Assigned Property, and all rights and privileges pertaining to said Trademarks in conformance with 15 U.S.C. §1060; 37 C.F.R. §3.16, together with the goodwill of the business symbolized by the mark, including all income, royalties, damages, and payments now or hereafter due or receivable in respect of the Assigned Property, and all causes of action (either in law or equity) and the right to sue, counterclaim, and recover for past, present, and future infringements, misappropriations, or dilutions of the rights assigned to Assignee hereunder, and all rights corresponding thereto throughout the world.
3. The "Trademarks" are subsisting and have not been adjudged invalid or unenforceable, in whole or in part.

And for the above-named consideration, ASSIGNOR does hereby agree to, at the request of said ASSIGNEE, execute any and all papers and documents and do all other and further lawful acts that said ASSIGNEE may deem necessary or desirable to perfect and vest in the ASSIGNEE the entire right, title and interest in the intellectual property being assigned.

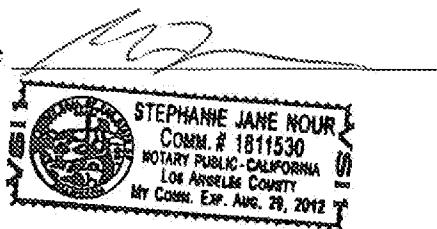
