TERMINATION AND RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST (hereinafter referred to as the "Release") is made as of the February 22, 2010, by THE PRUDENTIAL INSURANCE COMPANY OF AMERICA, an insurance company organized under the laws of New Jersey ("Releasor"), in favor of TestAmerica Analytical Testing Corp., a Delaware corporation, and TestAmerica Air Emission Corp., a Delaware corporation, and their respective successors and assigns (collectively "Releasee").

RECITAL

WHEREAS, Releasor acquired a first lien security interest in the intellectual property identified in the attached Exhibit A (the "Intellectual Property") pursuant to that certain Intellectual Property Security Agreement, dated as of January 3, 2003 (the "IP Security Agreement") with Releasee;

WHEREAS, the IP Security Agreement was recorded in the Assignment Division of the USPTO on June 26, 2003, on Reel 2768, Frame 0068, against the Intellectual Property;

WHEREAS, by execution of this Release, Releasor desires to grant to Releasee a termination and release of its security interests in, and its collateral right, title, and interest in and to, the Intellectual Property.

RELEASE

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Releasor hereby terminates and releases its security interest in and to the Intellectual Property, and Releasor further assigns and transfers to Releasee, and unto Releasee's successors and assigns, without recourse, all right, title, interest, claim, or demand whatsoever Releasor may have acquired in, through, or by the IP Security Agreement.
