RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of February 9, 2010 ("Effective Date") by and between Aqua Clear Industries, Inc. ("Grantor") and Norstar Bank of Upstate NY n/k/a Bank of America, N.A. (the "Administrative Agent").

WHEREAS, Grantor and the Administrative Agent entered into that certain Loan and Security Agreement by and between Grantor and the Administrative Agent dated January 30, 1991 (the "Loan and Security Agreement");

WHEREAS, pursuant to the Loan and Security Agreement, Grantor granted to the Administrative Agent a lien on and security interest in all of its right, title and interest in, to and under certain intellectual property, including the trademarks set forth on Schedule A hereto (the "Trademark Collateral"), and entered into that certain Memorandum of Security Agreement dated January 31, 1991 (the "Trademark Security Agreement") for the purpose of recording such security interest with respect to the Trademark Collateral with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 13, 1991, at Reel 0767, Frame 0996; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademark Collateral.


The Administrative Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.


