RELEASE OF SECURITY INTEREST IN TRADEMARKS

2. agrees that any power of attorney or similar rights granted by Grantor to Secured Party pursuant to the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
