TRADEMARK ASSIGNMENT**

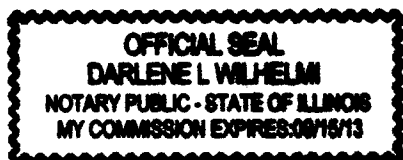


