

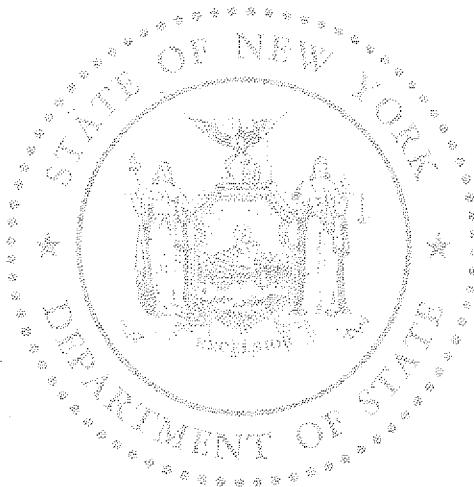

**CERTIFICATE OF MERGER OF
DITTUS COMMUNICATIONS, INC. INTO
FD U.S. COMMUNICATIONS, INC.**

Under Section 904 of the New York Business Corporation Law

1. The name of each constituent entity that is to merge is Dittus Communications, Inc., a District of Columbia corporation ("Dittus"), and FD U.S. Communications, Inc., a New York corporation ("FD U.S. Communications").
2. The certificate of incorporation of Dittus was filed with the Department of Consumer and Regulatory Affairs of the District of Columbia on May 6, 1999, and the certificate of incorporation for FD U.S. Communications was filed with the Secretary of State of the State of New York on August 10, 1982. FD U.S. Communications was originally formed under the name "Park Communications, Inc."
3. FD U.S. Communications is authorized to issue 20,000 Common Shares, par value \$1.00 per share, of which (i) 10,000 are designated Class A Common Shares and (ii) 10,000 of which are designated Class B Common Shares. Two Thousand, Five Hundred Sixty-Two (2,562) Class A Common Shares, are currently issued and outstanding.
4. Dittus is authorized to issue 10,000 shares of voting common stock with no par value, of which 1,000 are issued and outstanding.
5. Dittus has not filed an application for authority in New York.
6. An agreement and plan of merger (the "Plan") has been approved and executed by each constituent entity that is to merge. The Plan was adopted by unanimous written consent of the Board of Directors of FD U.S. Communications on December 22, 2009. The Plan was adopted by written consent of the sole stockholder of FD U.S. Communications on December 22, 2009. The Plan was adopted by unanimous written consent of the Board of Directors of Dittus on December 22, 2009. The Plan was adopted by written consent of the sole stockholder of Dittus on December 22, 2009.
7. The name of the surviving entity shall be "FD U.S. Communications, Inc."
8. There are no amendments or changes in the certificate of incorporation for FD U.S. Communications to be effected by the merger.
9. The effective date of the merger shall be December 31, 2009.
10. The merger is permitted by the laws of its jurisdiction and is in compliance therewith.
