ARTICLES OF AMENDMENT TO THE CHARTER

Pursuant to the provisions of Section 48-20-106 of the Tennessee Business Corporation Act, as amended, the undersigned corporation hereby adopts the following Articles of Amendment to its charter:

1. The name of the corporation is New ASC, Inc.
2. The corporation's charter is hereby amended as follows:

The text of Article I is hereby deleted in its entirety and replaced by the following text:

The name of the corporation is Aegis Sciences Corporation.
3. There will be no exchange, reclassification or cancellation of issued shares.
4. The amendment was duly adopted on December 7, 2006 by the directors and shareholders of the corporation.
5. The amendment is to be effective on January 1, 2007.
