CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Trademark Assignment (this "Assignment") is made on February 12, 2010 (the "Effective Date") by and between FD U.S. Communications, Inc., a New York corporation, (hereinafter "Assignor") and FTI Consulting, Inc., a Maryland corporation, (hereinafter "Assignee").

WHEREAS, pursuant to the merger of Dittus Communications, Inc. and Assignor, effective as of December 31, 2009, Assignor became the owner of all right, title and interest in and to the COMMUNITY POWER ALLIANCE trade/service mark, related marks and the applications, registrations, and common law rights therefore, including U.S. federal trademark registration number 3361117 (collectively the "Marks");

WHEREAS, the parties now wish to confirm the actual and legal transfer of the Marks from Assignor to Assignee.

NOW, THEREFORE, for good and valuable consideration previously given, the sufficiency and receipt of which are hereby acknowledged, it is confirmed that effective as of December 31, 2009, Assignor did assign, transfer and convey, and hereby ~~now~~ pro BONO assigns, transfers and conveys, unto Assignee, all right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement by the Marks, with the right to sue for, and collect the same for its own use and on behalf of its own successors, assigns, or other legal representatives.
