NUNC PRO TUNC TRADEMARK ASSIGNMENT

THIS NUNC PRO TUNC TRADEMARK ASSIGNMENT ("ASSIGNMENT") is hereby effective as of the 10th day of February 2005 (the "Effective Date") by and between: AQUA GUARD, LLC, a Washington limited liability company (hereinafter referred to as "Assignor") and CENORIN, LLC, a Washington limited liability company (hereinafter referred to as "Assignee").

WHEREAS, Assignor had adopted, used, was using, and to the best of Assignor's knowledge and belief, owned, controlled or otherwise had the rights to use the trademark AQUA GUARD;

WHEREAS, Assignor is the current record owner of U.S. Trademark Registration No. 1,187,320 for the mark AQUA GUARD ("Assignor's Registration");

WHEREAS, Assignor has and has acquired goodwill associated with Assignor's use of AQUA GUARD trademark;

WHEREAS, Assignee is desirous of acquiring all rights, title, and interest in and to Assignor's AQUA GUARD trademark, the Assignor's Registration, the goodwill associated with and symbolized by the AQUA GUARD trademark, and certain tangible assets which are associated with the goodwill of Assignor's AQUA GUARD trademark rights that have been transferred by Assignor;

WHEREAS, Assignor wishes to assign all of Assignor's rights, title and interest in and to the AQUA GUARD trademark and Assignor's Registration along with all the goodwill associated with the AQUA GUARD trademark;

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, Assignor hereby transfers to Assignee all rights, title, and interest as Assignor possesses in and to the trademark AQUA GUARD and Assignor's registration together with the goodwill symbolized by the AQUA GUARD trademark concurrent with the transfer of certain tangible assets as indicia of said goodwill.
