**THIS TRADEMARK ASSIGNMENT AGREEMENT** (this "Agreement") dated as of June 30, 2009, is made by and between Staples, Inc., a Delaware corporation ("Staples"), and Staples NA Integration, LLC, a Delaware limited liability company (the "LLC").

**WHEREAS**, the LLC merged with Corporate Express US, Inc., a Colorado corporation ("CEUS"), with the LLC as the surviving entity; and

**WHEREAS**, the LLC became the sole owner of all of the intellectual property and all goodwill associated therewith that was previously owned by CEUS; and

**WHEREAS**, Staples and the LLC have entered into an Intellectual Property Assignment Agreement, effective as of even date herewith at 6:30 p.m, pursuant to which the LLC has agreed to assign certain trademark rights to Staples.

**NOW, THEREFORE**, in consideration of the mutual premises, covenants and agreements contained in the Intellectual Property Assignment Agreement, the parties agree as follows:

**1. Assignment.** The LLC hereby transfers, conveys, grants and assigns to Staples, and Staples hereby accepts, all of its right, title and interest in and to the Marks (as defined below), including all claims for past infringement thereof and all income, royalties, damages and payments now or hereafter due or payable with respect thereto.


**2. Marks.** "Marks" shall mean trademarks, service marks, trade names, trade dress, logos, and other source or business identifiers which are the subject of the registrations and pending applications identified on Attachment 1 hereto, together with the goodwill associated with any of the foregoing, and all applications, registrations, renewals and extensions thereof.

**3. Filing.** The LLC hereby authorizes and requests the Commissioner of Patents and Trademarks and the corresponding entities and agencies in any applicable foreign countries to record Staples as the owner of the LLC's entire right, title and interest in and to the Marks.


**4. Counterparts; Signatures.** This Agreement may be executed in any number of counterparts with the same effect as if all of the parties had signed the same document. All counterparts shall be construed together and shall constitute one agreement. Facsimile and electronic signatures shall be deemed original signatures for all purposes of this Agreement.
