TRADEMARK ASSIGNMENT AGREEMENT

This Agreement is entered into by and between

General Motors LLC, a Delaware, U.S.A. limited liability company having a principal place of business at 300 Renaissance Center, Detroit, Michigan 48265-3000 ("GM"), and

Promark Global Advisors, Inc., a Delaware, U.S.A. corporation having a principal place of business at 767 Fifth Avenue, New York, NY 10153 ("Promark Global Advisors");

hereinafter referred to individually as a "Party" or collectively as the "Parties".

WHEREAS, Promark Global Advisors is a company under common ownership and control as GM;

WHEREAS, GM, through Promark Global Advisors, has used the PROMARK trademark in connection with "investment fund services and financial services" in the United States and other jurisdictions and has filed corresponding trademark applications in connection therewith ("PROMARK Trademarks"); and

WHEREAS, GM desires to assign the PROMARK Trademarks to Promark Global Advisors, and Promark Global Advisors desires to accept assignment of the PROMARK trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:


1. GM hereby assigns to Promark Global Advisors its entire right, title and interest in and to the PROMARK Trademarks, together with that part of the goodwill of GM's business symbolized by use of the PROMARK Trademarks.
2. This assignment includes the registrations and applications for the PROMARK trademark set forth on the attached Schedule A, attached hereto and incorporated herein by reference, as well as all right, title and interest the GM may have to the PROMARK Trademarks in connection with "investment fund services and financial services" in all countries or jurisdictions of the world, whether by use, registration, application or otherwise.
3. Promark Global Advisors hereby accepts assignment of the PROMARK Trademarks.
4. GM represents that it does not own any other registration or application for the PROMARK Trademarks in connection with "investment fund services or financial services" in any country or jurisdiction, other than that listed in the attached Schedule A,

and should same exist, by this assignment GM does hereby transfer all of its rights, title and interest thereto to Promark Global Advisors.

5. The Parties agree to execute any documents, reasonably requested by the other Party, to effectuate the intent of this Agreement.

The Parties hereto indicate their understanding of and full agreement with all of the foregoing by its duly authorized representative's signature below:


